Dear Participants,

This is with reference to the HRA training program and examination conducted on 22 April 2025 in Mumbai and 28 April 2025 in New Delhi for the Hygiene Rating Auditors under the HRAA Scheme.

The marks allocation for the examination is as follows:

A). Internal Assessment: 20 Marks

B). External Assessment (Examination) (MCQ + Descriptive): 80 Marks

The examination comprised 27 questions, of which questions 1-25 were multiple-choice questions (MCQs), each carrying 2 marks. Questions 26 and 27 were descriptive, each carrying 15 marks.

To qualify, participants are required to secure a minimum of 70% marks in both the internal assessment and the final examination, which together constitute a total of 100 marks (A + B).

- The **internal assessment** is evaluated out of 20 marks, and a minimum of 14 marks (70%) is required to pass.
- The **external examination** is evaluated out of 80 marks, and a minimum of 56 marks (70%) is required to pass.

Participants must achieve the 70% threshold in both assessments individually, as well as 70% cumulatively, to be deemed qualified.

Please refer to **Annexure - I** for Mumbai and **Annexure – II** for New Delhi for the list of participants who qualified as Hygiene Rating Auditors following the examination conducted on 22 April 2025 and 28 April 2025.

Note: Certificates of completion will be issued only to participants who successfully meet the qualifying criteria by passing the examination.

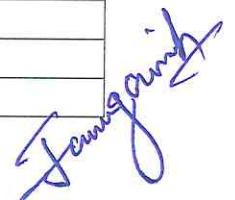
