This is with reference to the training program and examination conducted on 25 August 2025 for the Hygiene Rating Auditors under the HRAA Scheme.

The marks allocation for the examination was as follows:

- A). Internal Assessment:** 20 Marks
B). Final Examination (MCQ + Descriptive): 80 Marks

The examination comprised 27 questions, of which questions 1-25 were multiple-choice questions (MCQs), each carrying 2 marks. Questions 26 and 27 were descriptive, each carrying 15 marks.

To qualify, participants were required to score a minimum of 70% in both the internal assessment and the final examination, with a combined total of 100 marks (A + B).
